THREATS TO MEMBERS

Effective Date: May 9, 2005

POLICY

1. South Coast British Columbia Transportation Authority Police Service (SCBCTAPS) Members will immediately notify their Supervisor when becoming aware of threats to themselves, other Members, or a Member’s family, where the threat arises because of the police duties of the Member.

REASON FOR POLICY

2. To ensure the safety of a threatened Member and their family.

PROCEDURES

3. A Supervisor, upon receiving a report of a threat will:
 1. fully investigate the reliability of the information,
 2. notify as soon as practicable, the Watch Commander, or in the absence of the Watch Commander, the Supervisor in charge,
 3. obtain a detailed incident report from the Member, and
 4. forward this report, along with their own report outlining findings, through the chain of command to the Deputy Chief Officer. The following information will be included:
 - a. the threat level posed to the Member,
 - b. a recommendation as to whether the matter should be considered for future action, or kept on file for future reference.

4. The threatened Member’s Watch Commander, or in the absence of the Watch Commander, the Supervisor in charge, will:
