Chair Levine called the meeting to order at 9:02 a.m. and acknowledged that Metro Vancouver Transit Police operate throughout the traditional territories of the Lower Mainland Coast Salish peoples and is thankful for their hospitality on these lands. The meeting was duly constituted and a quorum was present.

3.1 Transit Police Professional Association

There was no report given.

3.2 Chief Officer Information Report – Chief Officer

The Board received a verbal report from Chief Jones regarding the following:

- Police Exemplary Medal Awards were held earlier this month
- COVID-19 pandemic update including:
 - Masks are mandatory within the Transit Police building and self-screening protocols continue for those coming into the workplace
 - No confirmed cases amongst staff to date
 - o Continue to monitor and maintain a good supply of PPE and cleaning products
 - o Staff continue to work remotely as much as possible
 - o Operational requirements are being met and staffing levels are good

Chief Jones commended the good work being done by members, responding to calls on and around the system regarding people in medical distress and administering naloxone.

Chief Jones also provided an update on a Transit Police member who was injured in a vehicle accident while responding to a call.

4. Other Business

4.1 Strategic Plan Update – Stephen Crosby

Mr. Crosby provided an update on the Strategic Plan process. Mr. Crosby shared a slide outlining the commitment statement and goals of the existing Strategic Plan (2016-2020). The Board met in October and November and work is underway to update the commitment statement. Mr. Crosby shared another slide in regards to the development of the new plan and the corresponding timeline is anticipated to be as follows:

- June 2021 First draft presented to the Board
- July/August 2021 Stakeholder Feedback
- September 2021 Second draft to Board
- November 2021 Final Draft to Board
- Q1 2022 Finalized and public release.

The Board discussed extending the current Strategic Plan for 2021 while the new plan is being developed. The following motion was put forward to extend the current plan and to keep Police Services apprised:

4.2 Diversity Initiatives

Diversity Initiatives is a standing item on the agenda for discussion. Chief Jones advised that Transit Police is engaged internally with their own diversity initiatives. Chief Jones, Inspector Kyle and Sergeant Simpkin will be taking part in a discussion with TransLink's Equity, Diversity and Inclusion Group to speak about issues in policing. Chief Jones provided an update on recruiting, education and training initiatives around diversity. In the recent sergeant promotion process, 40% of the promotions were female. Mentoring programs are available and have been successful. Board members shared comments and asked questions.

4.3 Report from Chair, Finance Committee

The Board received a verbal report from the Chair of the Finance Committee regarding recent activities of the Committee. The Committee approved their 2021 schedule at the last meeting.

4.4 Report from Chair, Governance Committee

The Board received a verbal report from the Chair of the Governance Committee on recent activities of the Committee including progress on Strengthening Indigenous Relations. Strategic planning is moving ahead and the Committee structure has been recommended for 2021. The Chair updated the Board on a recent meeting she attended with TransLink and noted the high level of work being done.
