# **Inspector Commendation**

### **Constable Julie Turtle and Constable Junjie Hu**

On December 19, 2021, Constable Julie Turtle and Constable Junjie Hu were on patrol when they responded to an incident at Metrotown Mall. A suspect had reportedly stabbed a female and had then fled from the crime scene. With other police units arriving at the mall, Constables Turtle and Hu headed a few blocks away where intuition told them the suspect might have fled.

As they began performing an area search southwest of Metrotown Station, they received an update from police dispatch that the suspect may be armed with a handgun as well as a knife. A short time later, the officers came across a man matching the description and successfully took him into custody at gunpoint. For their quick response in performing a systematic search resulting in the location and arrest of a homicide suspect, Constable Julie Turtle and Constable Junjie Hu are each presented with an Inspector Commendation.

# **Inspector Commendation**

#### **Constable Peter Kwok**

On May 7, 2022, a distraught man climbed onto a ledge at Granville Plaza, positioning himself above the train tracks 50 feet below. Constable Kwok responded and instantly determined the extreme

danger of the man falling to his death.

Recognizing the need to immediately build rapport, Constable Kwok engaged in verbal communication and negotiation with the man. Through the course of the conversation, Constable Kwok was able to successfully keep the man from jumping or falling until Vancouver Police negotiators could arrive. The man was eventually extracted from the ledge.

For his quick thinking in a crisis situation, which led to a successful conclusion, Constable Peter Kwok is presented with an Inspector Commendation.

#### **Constable Shawn Basi**

On June 6, 2021, Constable Shawn Basi and his partner responded to a report of a man bleeding profusely from his arm at New Westminster Station. Upon arrival, it was determined that the individual had suffered a cut to his right forearm. Constable Basi applied a tourniquet to prevent further bleeding. Constable Basi assisted with medical care until paramedics and fire services arrived. He then attended the hospital to check-in with the medical staff. It was determined that the

incident causing the man's sliced forearm had occurred in another municipality. Constable Basi spoke to the police of jurisdiction, who took on the police file for investigative follow-up.

For performing potentially life-saving first aid, Constable Shawn Basi is presented with an Inspector Commendation.

# **Deputy Chief Officer Commendation**

#### **Sergeant Gord McGuinness**

In In 2021, Sergeant Gord McGuinness developed the idea that the next Transit Police dogs would be named in honour of fallen Canadian police officers. He wanted to recognize the dedication of those fallen officers by deploying the newest canine team members as teams of three: handler, dog and honouree. In June 2022, Transit Police dogs Harnett and Chopper completed their training and

received their badges. Harnett is named for Sergeant Andrew Harnett of the Calgary Police Service and Chopper is named for Constable Ryan "Chopper" Masales of the Abbotsford Police Department. For recognizing the service of fallen police officers and finding a new way to honour their memory, Sergeant Gord McGuinness is presented with a Deputy Chief Officer Commendation.

#### **Constable Clint Hervias**

On October 29, 2021, Constable Clint Hervias was off duty and riding a SkyTrain approaching Surrey Central Station. Upon arrival, he heard yelling

and several loud bangs while passengers began running from the front to the rear of the train. Constable Hervias observed a man yelling at an unidentified group of passengers and striking sections of the train interior with a baseball bat. Constable Hervias pushed the emergency strip and intercom, and instructed a nearby passenger to phone 9-1-1. As the train approached Gateway Station, the man exited the train and began hitting the train exterior. Constable Hervias verbally engaged the man, instructing him to drop the bat. The man did not comply and continued to escalate his behavior.

At this point, Constable Hervias tactically engaged the man and removed the baseball bat. With the assistance of a nearby passenger, he took the man to the ground and subdued him until RCMP and additional Transit Police officers arrived. For going above and beyond to ensure passenger safety, Constable Clint Hervias is presented with a Deputy Chief Officer Commendation.

# **Deputy Chief Officer Commendation**

#### **Judy Parker**

Judy is a positive and engaged team player who has exceptional planning skills, which she consistently applies to proactive initiatives for the benefit of the department. Judy takes on

numerous tasks that are above and beyond the scope of her usual duties. In 2021, Judy created "The Informer" newsletter. This bimonthly newsletter is one of the most read communication pieces at Transit Police that significantly increases information sharing between different sworn and civilian sections.

Furthering support for the organization's culture and relationship building between employees, Judy was instrumental in the facilitation of an "Amazing Race" based NCO Training Day. This event left a lasting impression

## **Chief Officer Commendation**

#### **Beth Nielsen**

On November 23, 2022, the Community Safety Officer program was approved by the Provincial Government. This completed a three-year approval process that has required Senior Policy and Planning Advisor Beth Nielsen to provide supplementary material, often on a weekly basis, which

accounted for feedback from internal, government and community stakeholders.

The successful completion of this application and the establishment of a designated law enforcement unit is one of the most significant changes at Metro Vancouver Transit Police since inception.

Research into a Community Safety Officer program began back in 2017 with the examination of tiered policing models in Canada and the US. Beth assisted in the drafting of several reports, detailing legislative

and regulatory considerations. Beth then developed a formal application to the Province in 2020. Subsequently, Beth led revisions to the proposal in 2021 and 2022 based on feedback from the Ministry of Public Safety and Solicitor General, consulted community groups, as well as the Transit Police Board, Executive Team and TransLink.

For her extensive work in securing approval for a Transit Police Community Safety Officer program, Beth Nielsen is presented with a Chief Officer Commendation.
